G2 Grid® Report for Data Privacy Management


Products are ranked by customer satisfaction (based on user reviews) and market presence (based on market share, vendor size, and social impact) and placed into four categories on the Grid®:


DataGrail vs OneTrust: Ratings

Reviewers felt that DataGrail meets the needs of their business better than OneTrust.


When comparing quality of ongoing product support, reviewers felt that DataGrail is the preferred option.
